- 1. Rules and Regulations.** This Toll Schedule is subject to the Rules and Regulations governing the Transportation of Petroleum dated January 1, 2018 and issued by Pembina Pipeline Corporation, as amended, supplemented, modified or replaced from time to time (the "**Rules and Regulations**") and which are publicly available on Pembina's website at [www.pembina.com](http://www.pembina.com). Unless otherwise specified herein, in this Toll Schedule all words and terms defined in the Rules and Regulations shall have the meanings ascribed to them in the Rules and Regulations, and in this regard:
- 2. "Carrier"** means Pembina Prairie Facilities Ltd.

"**Delivery Point(s)**" means the following delivery points:

Alberta Ethane Gathering System	Liquid Ethane

"**Origin Point(s)**" means the origin points set forth in Section 5 of this Toll Schedule.

"**Petroleum**" means Liquid Ethane.

"**Pipeline System**" means the Vantage Pipeline.

- 3. Currency.** The tolls set forth in this Toll Schedule are listed in USD.
- 4. Specifications.** Petroleum tendered for transportation on the Pipeline System shall have the applicable specifications set forth in Appendix 1 to this Toll Schedule.
- 5. Non-Transportation Service Agreement (TSA) Shippers.** The tolls payable by non-TSA Shippers for the receipt, transportation and delivery of Petroleum shall be as follows:

- 6. Tolls.** The tolls of the Carrier are regulated by the Canada Energy Regulator (the Regulator) on a complaint basis. The Carrier is required to make copies of tariffs and supporting financial information readily available to interested persons. Persons who cannot resolve traffic, toll and tariff issues with the Carrier may file a complaint with the Regulator. In the absence of a complaint, the Board does not normally undertake a detailed examination of the Carrier's tolls.
